

# 4-H Alumni Large Market Animal Scholarship Application

*Purpose:* To provide financial assistance to deserving Large Market Animal 4-H Exhibitors per species per calendar year. Large Market Animal Exhibitors are required to meet age requirements for their selected species. Funds may be used to reimburse the purchase of the market animal, feed and supplies, housing, or veterinary expenses. Please Note: Financial Awards will be paid after the Erie County Fair.

A monetary scholarship will be awarded for the following projects:

**Market Steer or Dairy Steer**

**Market Hog**

**Market Lamb**

**Market Goat**

You may apply for more than one scholarship.

Funds may be allocated to another species for the year, depending on the number of applicants.

*Criteria:*

- Scholarship recipients will be selected based on valid current enrollment in Erie County 4-H, financial need, community service activities and other activities may play a role in the selection process.
- Completed application. Where there is more than one family member applying for the same scholarship, please remember to present your own data and not a copy of another family member.

- Required is a commitment to promote volunteerism through the 4-H Café at the Fair with the intent to advance this scholarship opportunity. Recipient **must** be prepared to volunteer during Erie County Fair specifically at the 4-H Café. (A minimum of 8 hours is required at the Café. Shifts are 4 hours and **cannot** be split). Online registration is RECOMMENDED on the CCE-Erie website available in June 2025.

Youth will be recognized at species meetings at the fair.

at the fair August 2025***

**Additional Conditions:**

- Upon receipt of this scholarship, I verify I will work and complete this project to the best of my ability and will consult with my 4-H educator if problems arise.

- The scholarship committee has the right to reject any and all applications received.
- I agree to document all volunteer activities. (A sign in sheet will be provided for you at the 4-H Café)
- Scholarship funds will not be awarded until enrollment/proof of ownership of my animal is verified through the livestock department of CCE **and** I have completed my volunteer service. Your enrollment in the project area is considered proof of ownership.
